AT THE SECONDARY LEVEL, THE LIFE SKILLS PROGRAM PROVIDES EDUCATIONAL SCHOLARSHIPS, LIFE SKILLS INSTRUCTION, AND VOCATIONAL AND TECHNICAL TRAINING.
